# registration in the EPR registry for producers/PROs



producer provides data according to the first Annex (producer registration)).



PRO provides according to the Second Annex (PRO registration) and in 10 days will get authorization approval in the EPR registry



After the registration in the EPR registry producer/PRO gets unique code and that means registration approval



Producer/PRO according to the third annex provides data reporting on products placed on the market

# producer registration

Producers of products which falls under EPR are obliged:

before products are placed on the market producer should be registered in the EPR registry (if not import can not be completed as the custom department does not allow import of plastic products)

## required information for the producer registration

- ✓ individual producer – name, family name, identification code
- ✓ legal entity – name, Identification code, type of activity
- ✓ contact information
- ✓ economic activity code
- ✓ information on the EPR products placed on the market of previous year and at the time of registration (weight, type of products in tones)
- ✓ information on the EPR products for the next year (prognoses) placing on the market (weight, type of products in tones)
- ✓ new producer is obliged for the registration in the EPR registry

## PROs obligations in the EPR registry

after authorization within the 10 days should be registered in the EPR registry

and provide following information:



Identification number



decree of Minister of Environmental Protection and Agriculture of Georgia issued by MEPA



contact information



collective PRO should provide information – identification numbers of member producers and the document which proves of producers membership

## reporting on the EPR products

produced on previous month in every next month (till 15<sup>th</sup>)

correction can be provided in the current month till 20th. after this deadline PRO can not provide any changes or corrections.

If reporting was not done during the month of the reporting period of time – the declaration must be submitted with zero amount.



# EPR streams and commodity codes

according to the decree of minister for each EPR stream products are defined commodity codes

- batteries and accumulators 29 positions of commodity codes
- Electric and Electronic products - 285 commodity codes positions
- tires – 16 commodity codes positions
- Oils - 11 commodity codes positions

# Deregistration from the EPR registry



producer self deregistration can do if they do not place EPR products in the market



PRO can be deregistered by the EPR administrator (MEPA) after 15 days of authorization abolished

registered producers in the sistem- 9938

- batteries and accumulators module - 1264 producer
- oil producers- 955
- tires producers - 915
- electric and electronic producers - 6804

# obligations of PRO members



after leaving pro membership – in 10 days producer should update his data in the EPR registry



in every six month (till 1st august and 1<sup>st</sup> February) provide information proved by Revenue Service (customs department) on imported products (weigh, type, in tone) trhue EPR electronic registry to the Ministry of Environmental Protection and Agriculture (MEPA)



each producer can join only one PRO stream and membership can be stopped after the end of reporting (accountability) period of PRO
